First International Scientific Conference "The multidimensionality of cybersecurity"

## 1. General provisions

### 2. Rules for participation and cancellation of participation







2.1 Participants in the Conference are research and research and teaching staff, as well as practitioners interested in the issue of multidimensionality of cybersecurity.

2.2 Successful registration of participation in the Conference (active and passive in the form of stationary and online) requires the completion of the registration form, located on the Conference website - by February 29, 2024, and sending it to: conference.cybersecurity@uth.edu.pl and payment of the fee - in the amount and by the deadline referred to in section 2.5.

2.3. The Organizer shall not be liable for damages resulting from the introduction of incorrect data by the Registrant in the registration form. The Organizer undertakes to keep confidential all information (data) obtained from the Registrant, with the exception of data intended for entry in the conference catalog and placed in the post-conference publication.

2.4 The conference may not be attended by persons who are ill.

2.5 The fee referred to in section 2.2. is:

• PLN 1,700 - in the case of accommodation in a single room; the fee includes the cost of accommodation, meals, participation in the gala dinners and post-conference publication, but does not cover travel costs;

• PLN 1400 - in the case of accommodation in a double room; the fee includes the cost of accommodation, meals, participation in the gala dinners and the post-conference publication, but does not cover the cost of travel;

• PLN 950 - in the case of participation in the conference without the use of accommodation (online active participation); the fee includes participation in the conference and the post-conference publication.

2.6 After registration and payment of the fee, a return e-mail will be sent confirming acceptance of the application. If you do not receive such confirmation, please contact the Conference organizer (conference.cybersecurity@uth.edu.pl).

2.7 Failure to pay the fee for participation in the Conference by the date specified by the Organizer in these regulations entitles the Organizer to cancel the application for participation, without incurring any liability for damages on this account.

2.8 At the individual request of the Conference Participant, the Organizer will issue a VAT invoice for participation in the Conference.

2.9. The participant of the Conference may resign from participation in the Conference.Statement of resignation from participation in the Conference should be made in writing.In case of cancellation of participation in the Conference, made no later than 21 days before the scheduled date of the Conference, the Participant is entitled to a refund of the entire amount paid.

However, if the cancellation is made later, the Participant is entitled to a refund of fifty percent of the paid amount.

2.10. The Organizer reserves the right to change the date of the conference and its cancellation, in a situation where there are reasons beyond its control, in particular, the organization of the event will be prevented by a pandemic situation.

### 3. Conference agenda and rules for speeches

3.1 The conference is held on April 24-26, 2024, in a hybrid format. It consists of the following plenary sessions:

- April 24: 3 p.m. 6:30 p.m,
- April 25: 9 a.m. 3 p.m,
- April 26: 9.00-11.00.

The detailed program of the Conference will be sent to the Participants at the latest one week before the Conference date, by e-mail. The organizers reserve the right to change the hours of the plenary sessions depending on the number of submitted papers.





3.2 Papers in English intended for post-conference publication should be submitted by March 15, 2024, to conference.cybersecurity@uth.edu.pl. They must not exceed 40,000 characters (including spaces and footnotes).

3.3 In the case of submission of a paper by a participant of the conference in co-authorship with another person, who is not a participant of the conference, to the fee referred to in sections 2.2. and 2.5. an additional fee of 200 PLN is added.

3.4 Papers may also be submitted by persons who did not participate - active or passive,

in the Conference. The condition for publication of the paper is to meet the deadline referred to in section 3.2. and payment of the fee in the amount of 700 PLN, and in the case of co-authorship 900 PLN, to the account number given in section 2.5. until February 29, 2024.

3.5. The papers should be accompanied by abstracts in Polish and English (each of 800 to 1200 characters including spaces). The text corresponding to the editorial requirements of UTH should be submitted in the form of an electronic record.

3.6 The selection of papers to be presented at the conference and for publication will be made by the scientific committee referred to in section 1.3. The author will be informed by e-mail about the acceptance of the paper.

### 4. Final provisions

4.1 Sending a registration application from the Conference website, implies acceptance of the provisions of these Regulations, as well as adherence to the rules of order and any other arrangements made between the Participant and the Organizer.

4.2 In accordance with the Act of August 29, 1997 on the protection of personal data (i.e. Dz. U. of 2019, item 1781), the Conference Organizer shall not transfer, sell or lend the collected personal data of Participants to other persons or institutions. The personal data provided by the Participant (name, address, telephone number, email address) is used only for the purposes of the Conference and communication between the Participant and the Conference Organizers.

4.3 In accordance with the Regulation of the European Parliament and of the Council (EU) 2016/679 of April 27, 2016 (RODO), the Conference Participant agrees to the processing of personal data, for purposes related to registration and participation in this event. At the same





time, he/she agrees to the free use of his/her image and voice for the purpose of developing documentation recording the course of the Event, as well as marketing materials related to it (photographic report, audio-video).
