# Warsaw - Falenty, 7-9 April 2025

### 1. General provisions

- 1.1. The Second International Scientific Conference "The multidimensionality of cybersecurity. Hate speech in cyberworld", hereinafter referred to as the "Conference", shall be held on 7-9 April 2025, (Green Garden Hotel, 50 Droga Hrabska St., 05-090 Falenty near Warsaw).

### 2. Rules of participation and cancellation of participation

2.1. Participants at the Conference include research and research and teaching staff, as well as practitioners interested in the multidimensionality of cyber security and hate speech.





- 2.2. Successful registration of participation in the Conference (active and passive in the form of stationary and online) requires completion of the <u>registration form</u> also found on the Conference website by 27 March 2025 and payment of the fee in the amount and by the deadline referred to in section 2.4.
- 2.3. The Organiser shall not be liable for any damage resulting from incorrect data being entered into the registration form by the Registrant. The Organiser undertakes to keep confidential all information (data) obtained from the Registrant, with the exception of data intended for entry in the conference catalogue and inclusion in the post-conference publication.
- 2.4. The fee referred to in section 2.2. is:
  - PLN 2,050 in the case of accommodation in a single room; the fee includes the costs
    of accommodation, meals, participation in the gala dinners and the post-conference
    publication, but does not cover travel costs;
  - PLN 1,750 in the case of accommodation in a double room; the fee includes accommodation, meals, participation in the gala dinners and the post-conference publication, but does not cover travel costs;
  - PLN 1,300 in the case of participation in the conference without the use of accommodation (active online participation); the fee includes participation in the conference and the post-conference publication.

The fee should be sent to the bank account Pekao SA 08 1240 6292 1111 0010 3988 3329, no later than 27 March 2025. In the title of the transfer, please indicate: 2nd International Scientific Conference "The Multidimensionality of cybersecurity. Hate speech and cyberworld", the name of the person to whom the transfer relates and the details of the institution represented.

- 2.5 Once the application has been submitted and the fee paid, a return e-mail will be sent confirming acceptance of the application. If you do not receive such confirmation, please contact the Conference organiser (conference cybersecurity@uth.edu.pl).
- 2.6 Failure to pay the fee for participation in the Conference by the date specified by the Organiser in these Regulations entitles the Organiser to cancel the registration of participation, without incurring any liability for damages on this account.
- 2.7 At the individual request of the Conference Participant, the Organiser will issue a VAT invoice for participation in the Conference.





2.8 A participant of the Conference may resign from participation in the Conference. The statement of resignation from the participation in the Conference should be made in writing and sent to the email address conference.cybersecurity@uth.edu.pl. In the case of resignation from the participation in the Conference, made no later than 21 days before the date of the planned Conference, the Participant shall be entitled to a refund of the entire amount paid. If the cancellation is made later, the Participant is entitled to a refund of fifty per cent of the paid amount.

2.9 The organiser reserves the right to change the date of the conference and to cancel it if reasons beyond its control occur, in particular if a pandemic makes it impossible to organise the event.

## 3. Conference agenda and rules for speeches

3.1. The conference takes place from 7-9 April 2025, in a hybrid format. It consists of the following plenary sessions:

- 7 April: 14.00-18.30,

- 8 April: 9.00-13.00 and 14:00 - 18:30

- 9 April: 9.00-11.00.

A detailed programme of the Conference will be sent to Participants at the latest one week prior to the Conference date, by e-mail. The organisers reserve the right to change the hours of the plenary sessions depending on the number of submitted papers.

- 3.2 Papers in English for post-conference publication should be submitted by 7 April 2025, to conference.cybersecurity@uth.edu.pl. They must not exceed 40,000 characters (including spaces and footnotes).
- 3.3 In the case of submission of a paper by a conference participant in co-authorship with another person, who is not a conference participant, an additional fee of PLN 200 shall be added to the fee referred to in sections 2.2. and 2.4.
- 3.4 Papers may also be submitted by persons who have not participated actively or passively, in the Conference. The prerequisite for the publication of the paper is to meet the deadline referred to





in section 3.2. and payment of the fee of PLN 850, or PLN 1050 in the case of co-authorship, to the account number given in section 2.4. by 23 March 2025.

- 3.5 The papers must be accompanied by abstracts in Polish and English (each between 800 and 1200 characters including spaces). The text corresponding to the editorial requirements of UTH should be submitted as an electronic transcript.
- 3.6 Authors are required to submit a copyright transfer statement regarding the use of the submitted paper.
- 3.7 The selection of papers to be presented at the conference and for publication will be made by the scientific committee referred to in section 1.3. The author will be informed of the acceptance of the paper by e-mail.

#### 4. Final provisions

- 4.1. By submitting the application form, the Participant accepts the provisions of these Rules and Regulations, as well as compliance with the rules of order and any other arrangements made between the Participant and the Organiser.
- 4.2. Pursuant to the Personal Data Protection Act of 29 August 1997 (i.e. Dz. U.
- 2019, item 1781), the Conference Organiser does not transfer, sell or lend the collected personal data of Participants to other persons or institutions. The personal data provided by the Participant (name, address, telephone number, e-mail address) is used only for the purposes of the Conference and communication between the Participant and the Conference Organisers.
- 4.3. In accordance with the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 (RODO), the Conference Participant agrees to the processing of personal data, for the purposes of registration and participation in this event. At the same time, he/she agrees to the free use of his/her image and voice for the purpose of developing documentation recording the course of the Event, as well as marketing materials related to it (photographic report, audio-video).
